TOTAL RELATIONSHIP BALANCE

- The closing prices of gold, securities holdings and wealth management on every trade day are used to calculate the average balance of previous three months.
- The balance of credit card account, utilized overdraft facilities of current account and utilized margin loan of securities margin account are excluded in calculating the Total Relationship Balance.

ACCOUNT BALANCES

- The balances listed in this column are the individual balances of each type of related accounts/products included in "Customer Portfolio". The "HKD Equivalent" is calculated using the relevant exchange rate of the last banking day in the month. The equivalent balance is for reference only.
- Securities Holdings is the market value of securities in hand while Securities Account Fund Holdings is the total amount of cash in the Securities Account.
